AEMA Membership Qualifications

Any person, firm or corporation with an interest in the Private Residence Elevator and Accessibility Equipment Industry is eligible to become a full voting member of the AEMA Association. This includes manufacturers, equipment users, architects, building owners, code writers, regulatory authorities, accessibility contractors, industry associations, government and others. (See the following excerpt from the bylaws.)

Excerpt from the AEMA Bylaws

The term "Private Residence Elevator and Accessibility Equipment" industry includes the design, manufacture, installation, servicing and maintenance of vertical, inclined and horizontal conveying systems which are used primarily to provide access and/or egress for persons in public and private residential environments, commonly known as platform lifts, stair-lifts, wheelchair lifts, access elevators, private residence elevators, stairway chairlifts, limited use/limited application elevators and similar products.

AEMA Code of Ethical Practices
